**Artisan Market Vendor
Rules & Regulations
June 14 & 15, 2019**

1. Vendor Applications are reviewed and evaluated in order of receipt. Booth spaces and electrical access will be assigned on a first come, first serve basis, until Festival capacity is reached.
2. Electrical access is provided for an additional flat fee of \$20. Vendors are limited to one outlet.
3. Applicants must meet all electrical codes and **MUST** provide their own heavy duty grounded exterior lead cord for hook up. If it is determined, at the sole discretion of the Greater Greenwich Chamber of Commerce (GGCC), that the applicant is using electricity for an unapproved or unsafe use, the GGCC may terminate electrical access with no advance notice.
4. All applicants must include a copy of their NYS Tax ID Certificate with their application and display their Tax Certificate during the festival.
5. All applicants must provide **(2) two photographs** of their products.
6. Subleasing of space is prohibited.
7. The Festival is held in Mowry Park and the surrounding area on Main Street (State Route 29) in the Village of Greenwich. **SETUP times on Friday, June 14 are between the hours of 12:00 PM and 5:00 PM and on Saturday, June 15 between the hours of 8:00 AM and 10:00 AM.** Upon arrival, please check in at the Chamber of Commerce tent in Mowry Park prior to setting up. In order to unload your items, you may temporarily park along Main Street, however, you must move your vehicle upon completion. Parking can be found on side streets and designated lots. No parking will be allowed in the Park. Applicant is responsible for removal of all trash, packing materials, boxes, etc. Security is not provided; please do not leave valuables unattended. Do let us know if you need assistance.
8. **Flea Market items and Flea Market type vendors are prohibited.** The Market will feature only handmade items created by artists/fine crafters from the local area. There will be NO vendors displaying imported and/or mass-produced items in the Artisan Market.
9. If it is determined, at the sole discretion of the GGCC, that the applicant is not in compliance with ANY of the regulations as set forth herein or fails to remove any display crafts or items upon request by the GGCC, that the Chamber considers incompatible with community or safety standards, the Chamber may expel the applicant from the Festival, without a refund.
