Rules & Regulations  
June 14 & 15, 2019**

**All Commercial Vendors (goods not handmade by the seller), Not-for-Profit Vendors, and Community Organizations will be assigned a vendor space on the lawns of TD Bank at 146 Main Street**

1. Booth spaces and electrical access will be assigned on a first come, first serve basis. Electrical access is provided for an additional fee of \$20. Vendors are limited to one outlet.
2. Applicants MUST meet all electrical codes and are required to provide their own heavy duty grounded exterior lead cords for hook up. If it is determined, at the sole discretion of the Greater Greenwich Chamber of Commerce, that the applicant is using electricity for an unapproved or unsafe use, the GGCC may terminate electrical access.
3. All applicants must include a copy of their **NYS Tax ID Certificate** with their application and display their Tax Certificate throughout the festival.
4. All applicants must provide two (2) photographs of the products they will be selling during the festival.
5. Subleasing of space is prohibited.
6. The Festival is held in Mowry Park and the surrounding area on Main Street (State Route 29) in the Village of Greenwich.
7. **Set up is on Friday, June 14 from 12:00 Noon to 5:00 PM and again on Saturday, June 15 from 8:00 AM to 10:00 AM ONLY.**
8. Check in is at the large green GGCC tent in Mowry Park prior to setting up.
9. Once you have been assigned your vendor space, you may temporarily load and unload along Main Street, but you must move your vehicle upon completion. Parking will be allowed on side streets and in designated lots only. No parking will be allowed in Mowry Park.
10. Applicant is responsible for the removal of all trash, packing materials, boxes, etc.
11. Security is not provided, so please do not leave valuables unattended.
12. **Flea Market items and Flea Market type vendors are prohibited.**
13. The Whipple City Festival is a family event. The GGCC reserves the right to reject any items listed on this application or from your display. **Prohibited items include, but are not limited to:** Switch blades, long knives, short knives, poppers, cap guns, smoke bombs, stink bombs, fireworks, stretch bottles, explosives, sticky string, silly string, marshmallow shooters, drug paraphernalia, laser pointer, lighters, tobacco products and alcoholic beverages.
14. If it is determined, at the sole discretion of the GGCC, that the applicant is not in compliance with ANY of the regulations as set forth herein or fails to remove any items upon request by the GGCC, that the GGCC considers incompatible with community or safety standards, the GGCC may expel the applicant from the Festival, without a refund.

I understand that my failure to abide by these rules may result in my expulsion from the festival this year and in the future.
